Joseph Connell Fowlkes, youngest of five children, was born January 20, 1949 to his loving parents, the late Walter and Ruth Fowlkes. He was called to rest on Wednesday, May 19, 2004 at the Sinai Hospital, Baltimore, Maryland. Joe or Connell (as he was affectionately called) was educated in the Baltimore City Public Schools and graduated from the Frederick Douglas High School in June 1967. He completed four years at Morgan State University, with a major in Mathematics. Connell attended Sunday school at the Fountain Baptist Church. Joe was employed by Blue Cross/Blue Shield as a Systems Analyst for over 20 years. He was constantly on call and played a major role in the systems strategies and development. He received much recognition for his work at Blue Cross/Blue Shield. He retired in 1998 on disability, because of his illness. Connell was a very intelligent, quiet, giving and unassuming person. His in-depth knowledge of so many subjects was often shared and sought by family, and especially his nephews, Marc and Bumper, in their early years. Joe was an avid sports fan and very supportive of the Baltimore Ravens. He, at one time, was also an avid chess player. Connell lived in the family home and was very devoted to loving and caring for our mother until her death. He will be greatly missed by all of us.
