Although he is predeceased by his stepfather Henry Fennell, he is survived by: his mother, Florence Fennell; and his three sisters, Margaret Anne Paxton, Frances Elizabeth Paxton and Vera Leigh Fennell; along with a host of loving aunts, uncles, cousins and close friends.
