Upon her graduation, she began a career at the original Provident Hospital where she served as a L. P. N. for thirty-eight years. During her long career, Lavinia acquired a degree in Anesthesiology. At the time of her retirement in 1996, she was the supervisor of central supply. In 1968, she married the love of her life whom she knew as a teenager John L. Willis. Lavinia was a very loving family oriented person. She enjoyed having family gatherings and being with friends. If she could help you in any way, she would. Lavinia loved her church family very much. She was a long-time member of Gospel Tabernacle Baptist Church where she remained an active member until her illness in 1996. Under the tutelage of the late Josephine Turner, she acquired and perfected her skills as a pianist. Her church family honored her for over twenty-five years of service as a church musician. Lavinia helped organize the Luke G. Reynolds memorial Choir and played the piano for them along with the Tapscott Gospel Chorus and the male Chorus. She was a member of the Pastor's Aid, Sisterhood, Nursing Ministry and a Flower Circle. She began attending gospel Tabernacle at a very, very young
