



## Vergie Deborah Anne Bell

September 13, 1944 - April 4, 2012

Vergie D. Bell, daughter of the late Samuel McKinley Fliggins and Mary Elva Lancaster was born on September 13, 1944 in Baltimore, Maryland. Vergie departed this life on Wednesday April 4, 2012.

She received her education in the Baltimore City Public School System. Her employment was as a Licensed Practical Nurse at Baltimore County General Hospital. She also worked as an Insurance Claims Adjuster for the State of New York and later transferred to the capital City of Albany.

She was saved in her early life under Elder Tyrone Griffin, and mastered as a believer under Bishop Doswell at Doswell Temple COGIC. After moving to New York in 1979, she became a faithful member of Washington Temple COGIC in Brooklyn, New York under the leadership of Jurisdictional Prelate Frederick Douglas Washington, where she remained for thirty-three years. She focused on mission and outreach ministry and obtained her license both as a Missionary and Deaconess after attending classes and graduating for the same. She was the President of the Nursing Unit, President of the Deaconess Board and Minister of Outreach; going into nursing homes and into prison ministry, through visually impaired. At her own expense, she commuted intra-state serving in both Carter Memorial COGIC and Washington Temple COGIC respectively. Sister Vergie was an indomitable force for the cause of the Kingdom of God. She remembered that her first mission field was not the

world at large, but instead her family where she was a constant force for good, teaching, preaching and lifting any and all who would hear her message of love and care. She mentored even to the second and third generation that followed her unbroken line of succession as a follower of Christ.

She leaves to cherish life and memory: children, Raynivene Fliggins, Byron lee and Edwin Norine Bell; brothers and sisters, Jesse Fliggins, Ida Elaine Fliggins, Elva Vonzella Richardson, Anthony Roland Fliggins Sr., Henry Lee Fliggins and Arthur Quantian Fliggins; and a host of grandchildren, great-grandchildren, many nieces, nephews and a very faithful friend, Gladys Hines of Brooklyn, New York.
